Dear Mr. Morris,

The Commission previously issued CoxCom, Inc., dba Cox Communications, a California Video Franchise (Franchise No. 0003) with an effective date of April 27, 2007. Consistent with California Public Utilities Code, section 5840(m) and General Order 169, Cox hereby notifies the Commission that CoxCom, Inc. recently completed a conversion and is now operating as a limited liability company, CoxCom, LLC, dba Cox Communications ("Cox").

CoxCom, Inc. was a corporation organized under Delaware law and is now operating as a limited liability company organized under Delaware law. With the conversion completed, CoxCom, LLC is deemed to be the same entity as CoxCom, Inc. The officers and directors of CoxCom, LLC are the same officers and directors that served CoxCom, Inc, and the conversion did not otherwise affect the ownership or management of the company.

General Order 169, Article VI(F) requires Cox to notify the Commission and affected Local Entities within fourteen business days of Cox completing a change of the video franchise holder's legal name or corporate organization, among other changes. Cox recently completed its conversion to CoxCom, LLC by filing with the California Secretary of State and receiving the attached Certificate of Registration. In addition to notifying the Commission, CoxCom LLC is sending a separate notice to each of the affected Local Entities.

CoxCom, LLC requests that the Commission issue an updated California Video Franchise Certificate that reflects the name change described herein.
