

Pursuant to the thirty-second application for an amendment of Franchise No. 0021, by Comcast Cable Communications Management, LLC, V1509001, granted on October 8, 2015, Comcast has reduced its franchise footprint by eliminating the Cities of Coalinga, Gustine, Huron and Williams as Affected Local Entities, and withdrawing territory in Colusa County and Merced County.
