## Overview:

In [Decision 20-05-053](#), approving PG&E's reorganization plan resolving the insolvency proceeding, the Commission ordered PG&E to file an application for regional restructuring. Regional restructuring is one governance change the Commission ordered PG&E to implement as a condition of approval of its reorganization plan. The Commission found that regional restructuring has the potential to improve PG&E's safety performance and responsiveness to local communities. In compliance with the Decision, PG&E filed an application with a proposed regionalization approach on June 30, 2020. Due to the short timeline between adoption of D.20-05-053 and the filing of PG&E's regionalization application, there was general consensus among parties to the proceeding that PG&E's application would benefit from additional public input in

order to further develop its proposal and subsequently submit a revised proposal to the Commission.

## Objective:

Pursuant to President Batjer's October 2, 2020, Scoping Memo and Ruling for this proceeding, the primary purpose of this workshop is for PG&E to receive input and feedback from parties and the public to help PG&E further develop and refine its regionalization proposal. Parties to the proceeding will file comments in the proceeding on the proposal by December 16, 2020. PG&E is required to submit a revised proposal by January 14, 2021.
