Background: The purpose of this workshop is to discuss parties’ proposals on modifications to the Central Procurement Entity (CPE) structure and hybrid framework, as directed by the [Scoping Memo](#) in [R. 21-10-002](#). This workshop and the proposals are part of the proceeding’s Phase 1 Implementation Track.

On October 15, 2021, the Commission opened a Rulemaking to address procurement obligations for Load Serving Entities (LSE) and to consider broader structural reforms to the Resource Adequacy (RA) program. On December 2, 2021, the Assigned Commissioner issued a Scoping Memo and Ruling (Scoping Memo) that set forth the scope of issues and schedule for the proceeding; the Scoping Memo divided the proceeding into the Implementation and Reform Tracks.

As part of the Implementation Track, parties are directed to file their CPE modification proposals on December 13, and new proposals on December 23, 2021. Comments on all proposals and the workshop are to be filed by January 4, 2022, with reply comments due on January 13, 2022. A Proposed Decision on Phase 1 is scheduled to be issued by February 2022, with a Final Decision that concludes this phase issued in March 2022.
