## Draft Version 2.0 of CPUC Environmental & Social Justice Action Plan Accepting Public Comment

A draft of the California Public Utilities Commission's (CPUC) [Environmental and Social Justice \(ESJ\) Action Plan](#) Version 2.0 is now available, and the CPUC is accepting public comment through Nov. 24, 2021.

The ESJ Action Plan serves as a commitment to furthering the principles of environmental and social justice, and acts as an operating framework to integrate ESJ considerations throughout the CPUC's work. The first version of the CPUC's ESJ Action Plan was adopted in February 2019.

The ESJ Action Plan establishes a definition of ESJ communities for the purposes of CPUC policy and programs. It consists of nine overarching goals, clear objectives, and 95 concrete action

items to ensure agency-wide collaboration, accountability, and forward movement in meeting ESJ principles. The nine goals are:

- Consistently integrate equity and access considerations throughout CPUC proceedings and other efforts.
- Increase investment in clean energy resources to benefit ESJ communities, especially to improve local air quality and public health.
- Strive to improve access to high-quality water, communications, and transportation services for ESJ communities.
- Increase climate resiliency in ESJ communities.
- Enhance outreach and public participation opportunities for ESJ commu-

nities to meaningfully participate in the CPUC's decision-making process and benefit from CPUC programs.

- Enhance enforcement to ensure safety and consumer protection for ESJ communities.
- Promote economic and workforce development opportunities in ESJ communities.
- Improve training and staff development related to ESJ issues within the CPUC's jurisdiction.
- Monitor the CPUC's ESJ efforts to evaluate how they are achieving their objectives.

Since the adoption of the first ESJ Action Plan, the CPUC has made significant progress in incorporating ESJ

# Pit River Tribe Celebrates New Ownership of Ancestral Lands

The [Pit River Tribe](#) celebrated the acceptance of 789 acres within the Hat Creek Watershed with a ribbon cutting ceremony on November 5, 2021 near the town of Cassel in Shasta County. Tribal leaders, members, and youth joined representatives from the CPUC, Pacific Gas and Electric Company (PG&E), the [Pacific Forest and Watershed Lands Stewardship Council](#), [Shasta Land Trust](#), and community members to commemorate the formal return of this special land to the Pit River Tribe.

The lands are within the ancestral territories of both the Illmawi and Atsugewi Bands, two of the 11 bands of the Pit River Tribe. The Hat Creek property is the first of four properties transferred to the Pit River Tribe from PG&E in accordance with PG&E's Land Conservation Commitment. The transfer of almost 6,000 acres to the Tribe, as well as the earlier creation of the Stewardship Council itself, is part of a large package of public benefits that was ordered as part of the CPUC's review of PG&E's 2003 bankruptcy settlement, which required PG&E to permanently conserve approximately 140,000 acres of PG&E Watershed Lands across the Sierra Nevada, southern Cascade, and

Coastal mountain ranges. Over the past 17 years, the Stewardship Council has developed and approved plans to provide permanent public benefit, stewardship, and conservation for lands held by PG&E for most of the last century.

Tribal Leader and Pit River Tribal Environmental Director Gregory Feather Wolfen attended the event with his wife and children. He shared that, "Under Tribal ownership once again, we plan to enhance ecosystem functionality of the properties, preserve open space, and uphold the conservation values while recognizing Indigenous based TEK [traditional ecological knowledge] and tribal protocols."

The Pit River Tribe has a clear vision for the land – it will continue to be a natural passive park, providing unique opportunities for the public to bird watch, hike, and picnic. Ownership of the Hat Creek property will allow the Pit River Tribe's cultural heritage to be nurtured, while protecting the existing beneficial public values on the property such as outdoor recreation and habitat and ensuring continued public access.

"The transfer of the land at Hat Creek from PG&E back to the rightful holders, the Pit River Tribe, is a small step toward

justice. I look forward to seeing future transfers of this kind back to our tribal communities as we follow their leadership for the restoration of the critical habitats and their partnership toward a clean energy future," said CPUC Commissioner Genevieve Shiroma.

Added CPUC Commissioner Darcie L. Houck, "This marks the long overdue return of the Hat Creek lands to the Pit River Tribe. The tribe has been seeking return of these lands for far too long, including the last roughly two decades through the Stewardship Council process. The efforts made that resulted in the return of the land to its Native caretakers is truly something we can all celebrate." ■



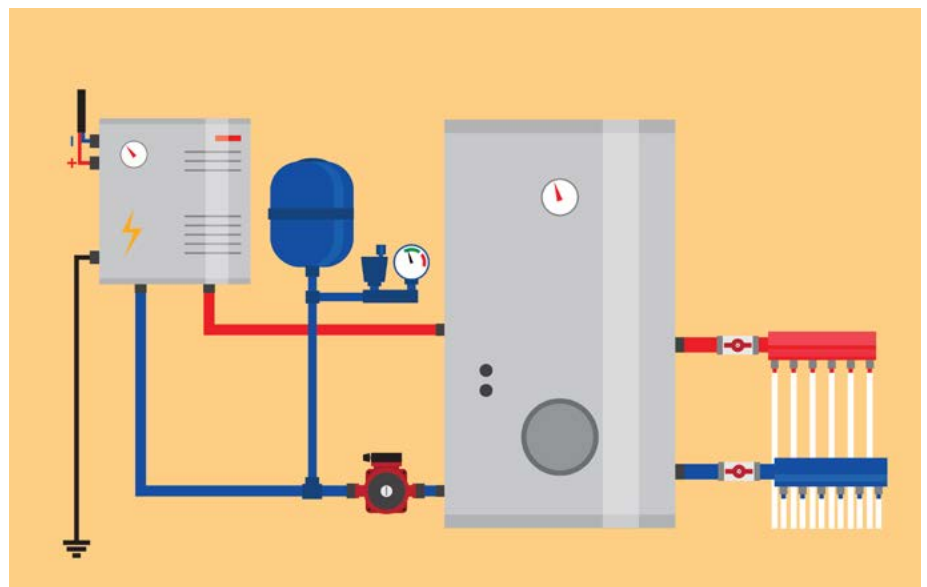
# CPUC Program Helps Homeowners Impacted by Wildfire Rebuild All-Electric Homes and Reduces Costs for Adoption of Electric Heat Pump Space and Water Heaters

The CPUC, in ongoing decarbonization actions to safeguard the environment, has created a new fund to help victims of wildfires and other disasters rebuild all-electric homes, adopted guidelines to make it easier for customers to use incentives from various programs, and directed large energy utilities to take steps to ensure that customers are not penalized with higher bills for switching from natural gas to highly efficient electric appliances.

The new Wildfire and Natural Disaster Resiliency Rebuild (WNDRR) Program is a 10-year, \$50 million program. It will provide incentives for customers who lose their homes to natural disasters to rebuild all-electric in alignment with the state’s climate and energy goals. Participants from disadvantaged communities will receive higher incentives. The program is open to eligible customers in all of the CPUC-regulated energy utility service territories.

The CPUC also adopted a set of guiding principles to ensure that customers can more easily access and combine incentives from the CPUC’s many building decarbonization programs, which have a combined budget of more than \$440 million. The principles focus on simplifying customer participation and ensuring

access for low-income customers. The CPUC also directed California’s three large electric utilities to revisit their rates, if needed, to ensure that customers are not penalized for switching from natural gas water heaters to highly efficient electric heat pump water heaters. ■

considerations into its work, including creating a culture that takes into account the lived experiences of ESJ communities. A Status Report on Version 1.0 was published in May 2020, which outlined the progress and implementation of each action item in the ESJ Action Plan. Highlights of accomplishments thus far include:

- Established an internal guidance for CPUC staff to incorporate ESJ issues into all proceedings;
- Added a new Public Comment feature to the CPUC [Docket Card](#) to encourage wider public participation;
- Continued and deepened prioritizations of ESJ communities and related issues in key proceedings and programs, including the Climate Adaptation proceeding ([R.18-04-019](#)) and the Affordability proceeding ([R. 18-07-006](#));

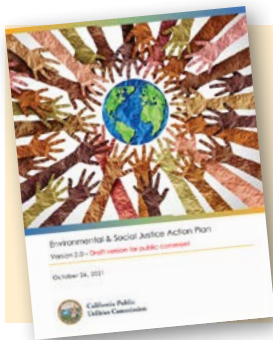
- Established new requirements for utilities to perform in-language outreach in the instance of wildfires and other disasters ([D. 20-03-004](#));
- Launched an overhauled CPUC [web-site](#), with a focus on consumer needs;
- Established a session on ESJ issues for the CPUC's New Employee Orientation;
- Began participation in the Capitol Collaborative on Race and Equity (CCORE);
- Entered a Memorandum of Understanding (MOU) with the California Workforce Development Board (CWDB) to provide expertise and recommendations on maximizing job access for ESJ communities;
- Published "[Economic Opportunities in Environmental and Social Justice Communities](#)," which outlined the success of the Utility Supplier Diver-

sity Program in reaching ESJ communities; and,

- Continued to emphasize outreach and engagement with community-based organizations.

For Version 2.0 of ESJ Action Plan, the underlying objectives of the nine goals have been enhanced, reflecting feedback received at a February 2021 workshop and comments gathered across a wide array of CPUC activities, including advisory group meetings, proceedings, and CPUC Voting Meetings. The goals remain the same, with the exception of Goal 7 related to workforce development, which has been revised to include an emphasis on job quality and access. The draft contains 91 new action items that reflect present-day priorities and efforts.

Once public comment is received, CPUC staff will review the comments and consider making additional changes to the draft ESJ Action Plan. A final draft will be posted in advance of a CPUC Voting Meeting, where CPUC Commissioners will vote to adopt the ESJ Action Plan Version 2.0 in 2022. ■
